### A INTRODUCTION AND PURPOSE

#### A1 Introduction

A1.1 This document is a subsidiary document to the Principles and Rules of Operation (the EECS Rules) of the Association of Issuing Bodies (AIB) for The European Energy Certification System (EECS).

A1.2 Specific reference is made to the EECS Rules Sections:

- (a) C – Harmonisation Measures
- (b) L – Change Procedures
- (c) M - General

A1.3 This document is subject to the change management procedures set out in Section L of the EECS Rules and related subsidiary documents.

#### A2 Purpose

A2.1 The purpose of this EECS Rules subsidiary document is set out the detailed procedural and technical matters associated with Independent Criteria Schemes and Labels. This will specifically include:

- Role of EECS in supporting an ICS or a Label
- Recognition of an ICS or a Label by the AIB
- Support of an ICS or a Label by a Scheme Member
- Cessation of support for an ICS or a Label.

A2.2 This document is also intended to provide further explanation of the procedures associated with Independent Criteria Schemes and Labels set out in the EECS Rules.

## INDEPENDENT CRITERIA SCHEMES

### B Definitions

B1 In this Subsidiary Document, unless the context otherwise requires or there is express provision to the contrary, terms shall have the meanings respectively ascribed to them in the EECS Rules:

TERM	MEANING
Label (or Label Flag)	Attribute on a Certificate reflecting that the Output and/or Production Device and/or Input to which a Certificate relates, conforms to a specific set of qualities defined in a Label Scheme, following an agreement between the Authorised Issuing Body and the corresponding Label Scheme Operator;
Independent Criteria Scheme (ICS)	A scheme for Certificates that provides assurance that the Output certified by an EECS Certificate, and/or the relevant Production Device with which it is associated, conforms to a specific set of qualities. ICS Certificates can be either Legislative Certificates or Non-Governmental Certificates;
ICS Operator	An organisation that offers one or more Independent Criteria Schemes
Label Scheme	Scheme with criteria independent from the criteria for Certificate Issuing, that provides assurance that the Output and/or the Production Device to which a Certificate relates, conforms to specific requirements which are additional to those established for the EECS Product
Label Scheme Operator	In relation to a Label Scheme, the body responsible for the rules establishing the operation of that Label Scheme
Legislative Certificate (LC)	A Certificate issued under a Legislative Certification Scheme
Legislative Certification Scheme	A Certification Scheme implemented pursuant to the law of any EU Member State or a State bound to the EU by a Treaty requiring the recognition of GOs or of any other State accepted by the AIB
Non-Governmental Certificate (NGC)	A type of Certificate, issued under an Independent Criteria Scheme which is not issued in the framework of a Legislative Certification Scheme

### C EECS in relation to Labels and ICSs

#### C1 Role of EECS

C1.1 The EECS Transfer System facilitates a Label by associating it with an EECS Certificate to provide traceability. Accreditation of Production Devices to a Label Scheme and any activities required at the point of consuming that Certificate beyond Cancellation are outside the scope of the EECS Transfer System.

C1.2 The EECS framework facilitates certificates to be acknowledged under EECS as ICS Certificates. These may be either Legislative Certificates that are not yet otherwise defined in the EECS Rules or Non-governmental Certificates (NGCs).

- C1.3 Experience gained with the operation of NGCs may support the development of Legislative Certificates Schemes. NGCs in EECS allow pioneering certificate markets to develop.
- C1.4 A Certificate, whether legislative or non-governmental, can only be called an EECS Certificate, if it is issued by a Member to the relevant EECS Scheme.
- C2 Label Flag**
- C2.1 The presence of a Label Flag on an EECS Certificate indicates that the corresponding Output fulfils the additional criteria of a specific Label Scheme. An EECS Certificate may carry more than one Label Flag.
- C3 ICS**
- C3.1 An ICS that is acknowledged by AIB is an EECS Product issued under a scheme for Certificates that provides assurance that the Output certified by an EECS Certificate, and/or the relevant Production Device with which it is associated, conforms to a specific set of criteria/requirements/conditions. If the ICS is not operated by AIB and thus not explicitly included in the EECS Rules, the Scheme Operator must have entered into an agreement with the AIB regarding the operation of that ICS Scheme. In this regard, the criteria set-out in section G must be met.

## D Recognition of a Label or an ICS by the AIB

### D1 Application

- D1.1 The organisation applying for recognition of its Label Scheme or its ICS shall complete respectively a Label/ICS application form (see Appendix 2) which requires the applicant to:
- Confirm that it agrees to the contractual conditions specified by the AIB;
  - Provide details of the organisation that operates respectively the Label or the ICS, including contact and financial details;
  - Provide a definition of the Label or ICS, including criteria and verification procedures; and
  - Provide a list of those Domains in which Scheme Members have agreed to place Label Flags for this Label Scheme onto EECS Certificates at Issue (note: the list of domains can be updated later), or a list of those Domains that issue Certificates under this ICS.
- D1.2 The applicant shall send the completed application form to the AIB Secretary General.
- D1.2.1 For Label Schemes this shall go along with confirmation of agreement to place Label Flags for this Label Scheme onto EECS Certificates at Issue from at least one of the Scheme Members whose Domains are listed according to section D1.1(d), and that at least one additional Scheme Member confirms to grant access to its Account Holders to the respective Label information on the EECS Certificate.
- D1.2.2 For an ICS it shall be confirmed that the criteria set out in section G are met and that at least one (applying) EECS Scheme Member will issue EECS Certificates under this ICS and at least one other (applying) EECS Scheme Member will import those EECS Certificates, unless otherwise agreed by the relevant Scheme Group.
- D1.3 On receipt of the completed application and supporting documents, the Secretary General will convene an Assessment Panel to review the application for the ICS/Label Scheme.

### D2 Approval

- D2.1 The Assessment Panel for the ICS/Label Scheme will determine whether the operational requirements of the proposed ICS or Label Scheme are consistent with the EECS Rules as apply to the Legislative Certification Scheme or Non-Governmental Certificate to which the Label Flag association or ICS acceptance is proposed. For Labels, it will also verify that the applicant has established an agreement with the relevant Scheme Members to Issue EECS Certificates with

the relevant Label Flag. For an ICS, it will also verify whether the conditions set out in section G are met.

D2.2 The Assessment Panel for the ICS/Label Scheme shall not unreasonably withhold recommendation for approval.

D2.3 The submitted Assessment Panel report will be placed on the agenda of the next Scheme Group meeting for acceptance decision after the EECS Unit has been consulted and any advice from the EECS Unit is taken into account in the decision of the relevant Scheme Group. When the ICS/Label Scheme application relates to more than one EECS Scheme, the assessment report will be for acceptance decision to the EECS Unit. The decision paper will include an implementation date from which the Label Flag for this Label Scheme can be used or from which production period start date the Certificates Issued under this ICS can be considered EECS Certificates.

### D3 Implementation

D3.1 Prior to the implementation date of the Label/ICS in connection with EECS, the General Secretary will update the EECS Rules Fact Sheet “*EECS Scheme Members and EECS Products*” to include the new Label/ICS, with hyperlinks to any relevant documents.

D3.2 The Label Scheme/ICS Operator will notify each Scheme Member listed under section D1.1(d) of the Production Devices located in that Scheme Member’s Domain and their effective dates of accreditation.

D3.3 The Scheme Member for each Domain listed in accordance with Section D1.1(d) shall make the appropriate adjustments to its Registry and its operating procedures to facilitate Issuing EECS Certificates with the Label Flag or, for an ICS, as the relevant EECS Product. It will also amend its Domain Protocol to include the issuance of the relevant EECS Product(s) with a Label Flag, where relevant. All Members to an EECS Scheme are entitled to import and export the respective ICS Certificates. All Scheme Members shall ensure their Registries can maintain the Label information of any imported certificates, in accordance with the Immutability principle of EECS.

D3.4 A Scheme Member listed in Section D1.1(d) must display the relevant Label or ICS on its registry and any relevant Cancellation Statements that it produces in relation to an EECS Certificate held on its registry; and a Scheme Member that is not listed in Section D1.1(d) may do so at its own discretion.

### D4 Changes to the Label Scheme / ICS Criteria

D4.1 In the event of a proposed change to the criteria or use of a Label or an ICS, the Label Scheme or ICS Operator must reapply for approval of the Label/ICS in advance of the implementation of that change.

## E Cessation of Support for a Label or an ICS

### E1 Conditions of Cessation

E1.1 The conditions under which the AIB may cease to support a Label or ICS include (*inter alia*):

- (a) Notification of cessation to the AIB by the Scheme Operator of the Label or ICS;
- (b) Insolvency or cessation of operation of the Scheme Operator of the Label or ICS;
- (c) No Scheme Members have Issued EECS Certificates with the relevant Label Flag in the last 12 months;
- (d) For the relevant ICS, the criteria in section G below are no longer met or there no longer exists a Scheme Member that is/will be issuing EECS Certificates under this ICS;
- (e) Absence of any evidence from the Operator of the Label or ICS of the use of the Label/ICS by energy suppliers or consumers in the last 12 months;

- (f) A change to the criteria applied by the Operator of the Label or ICS from the information given in the latest application form without the approval of the AIB prior to implementation;
- (g) Failure by the Operator of the Label or ICS to pay the annual ICS or Label fee;
- (h) Failure to comply with the conditions of support identified in the Application; or
- (i) A substantiated complaint by a Scheme Member that is upheld by the Scheme Group.

### E2 **Determination of Cessation**

- E2.1 Except where the Label Scheme or ICS ceases to operate by notification of the Operator of the Label or ICS, or that Operator is no longer in operation, the determination to cease support will be by a decision of the Scheme Group.
- E2.2 The General Secretary will instruct all Scheme Members to stop Issuing EECS Certificates with the relevant Label Flag(s) respectively ICS following:
- (a) A decision of the Scheme Group to cease support; or
  - (b) Notification from the Operator of the Label or ICS of his intent to stop; or
  - (c) Non-payment of annual fee where one is due; or
  - (d) An official report of the insolvency or cessation of operation of the Operator of the Label or ICS.
- E2.3 The General Secretary will determine an appropriate effective date of cessation and include this in the instruction in section E2.2.

### E3 **Actions upon Cessation of Support for a Label or an ICS**

- E3.1 From the effective date of cessation of support for a Label or an ICS, no Scheme Member may Issue an EECS Certificate with the relevant Label Flag nor consider a Certificate issued under this ICS to be an EECS Certificate.
- E3.2 An existing EECS Certificate under an ICS, or carrying a Label Flag for a Label Scheme which is no longer supported, may retain the Label Flag or exist as such EECS ICS Certificate until such time as that Certificate is Cancelled, or Expires, or is Withdrawn.
- E3.3 No further Label Scheme or ICS fees will become due.

## F **Fees for Label Schemes or ICSs**

### F1 **Application Fee**

- F1.1 The Application fee for a Label Scheme or ICS shall be calculated as sufficient to cover the AIB's cost of administering the application. This shall not include any costs of its Scheme Members except in relation to the participation in an ICS Assessment Panel.
- F1.2 The Scheme Group will determine the application fee on an annual basis. When the ICS/Label Scheme application relates to all EECS Schemes, this is determined by the EECS Unit.

### F2 **Annual Fee**

- F2.1 The annual fee for a Label Scheme or ICS shall be calculated as sufficient to cover the ongoing administration of support provided by the AIB itself and shall not include the costs of any of its Scheme Members.
- F2.2 The Scheme Group will determine the annual fee for a Label Scheme or ICS on an as required basis. When the ICS/Label Scheme application relates to all EECS Schemes, this is determined by the EECS Unit.

### F3 **Payment of fees for a Label Scheme or ICS**

- F3.1 The application fee will be payable on application.

F3.2 The annual fee will become payable on 1<sup>st</sup> April for the ongoing year.

### **G Criteria for acceptance as EECS Product for an ICS operated externally to the AIB**

In execution of EECS Rules section D2.4.1 (b), the requirements below shall be part of an agreement with the operator of an Independent Criteria Scheme.

#### **G1 Clear scope**

G1.1 The ICS should present clear boundaries with regard to Energy Carrier, Geographical Scope, purpose, technology. This enables to identify any areas of overlap.

#### **G2 Shared geographical scope**

G2.1 The agreement between AIB and the ICS Scheme operator would take place inside the “smallest” joint geographical scope, i.e. at maximum the AIB scope. This implies that only in AIB’s geographical scope, the respective ICS Certificates may be called EECS Certificates. Once they are leaving outside the control of an AIB Member or outside AIB’s geographical scope, they can no longer be called EECS Certificates.

G2.2 A reliable operation outside this scope is also of relevance for maintenance of the status of the EECS standard. Therefore, AIB shall retain the right to step out of the agreement in case of the ICS Scheme being operated in any geographical scope in a way that would cause harm to the credibility of the NGC, AIB or the EECS standard.

#### **G3 EECS Compliance**

G3.1 The ICS must show compliance with the EECS rules. The ICS scheme must show strong internal operations and compliance of its processes with the schemes in the EECS rules. Avoid double counting: ensure in the ICS Rules that ICSs should avoid that the attributes of the same energy can be claimed as such more than once.

#### **G4 Not competing with GO schemes and other legislative schemes**

G4.1 For an NGC, when a GO Scheme, or other Legislative Certificate Scheme for the same Purpose and the same Energy Carrier, is being set up in a Domain, this prevails over the NGC. The NGC Scheme Operator shall withdraw its operations for the area where a respective issuing Body is mandated by its legislative framework. The NGC Issuing Body for Certificates with the Purpose of Disclosure shall withdraw once a GO issuing body is appointed for a Domain, however a phase-out period may be agreed. Exception: If the NGC continues to exist in a GO Domain, there shall be a clear agreement with the GO issuing body avoiding double counting.

#### **G5 Clear authorisation and compliance criteria for issuing bodies under the ICS**

G5.1 The ICS must describe its authorisation criteria for issuing bodies under the ICS. It shall also clarify how IBs under the ICS are audited (or how quality is reassured).

#### **G6 Use of AIB’s facilities and role in AIB’s decision making**

G6.1 The agreement between AIB and the ICS operator must define whether and under what conditions the ICS operator may use the facilities provided by the AIB, such as the Hub or the Secretariat and its staff.

#### **G7 Scheme updating framework**

G7.1 The ICS must describe its procedures for Scheme updates and inform AIB of every scheme update. The agreement between AIB and the ICS operator must describe the maintenance of

alignment between the ICS rules and the (relevant part of the) EECS Rules in case any of the two are updated.

G7.2 The ICS or its operator should clarify the structure of decision making under the ICS.

### G8 **Legal entity operating the Scheme**

G8.1 In order to be able to enter into an agreement with the Scheme Operator of an ICS, this scheme operator shall be a legal entity. Only then, the party entering into an agreement with AIB, can be held liable for its commitments under the agreement.

### G9 **Exit conditions**

G9.1 The agreement between AIB and the ICS operator should describe the conditions for ending the agreement, how the cooperation will be phased out, etc.
